ORDER OF TERMINATION OF STIPULATION

NOW on this 17th day of February, 1996, comes for conference hearing before the full Board Licensee's request for termination of the Stipulation and Agreement and Enforcement Order of February 27, 1995 ("Stipulation") between Marc K. Hutchison ("Licensee") and the Board of Healing Arts ("Board"). Lori Miskel McNett, Associate Counsel, appears on behalf of the Board. Licensee appears in person and by and through his counsel, Reid F. Holbrook. Judy Janes appears on behalf of the Kansas Medical Society and Licensee.

After hearing statements from the parties and being duly advised in the premises, the Board makes the following findings of fact, conclusions of law and orders:

1. The Stipulation was entered into between Licensee and the Board on February 27, 1995.
2. An Order Modifying Stipulation and Agreement and Enforcement Order was entered on September 5, 1995, lifting two requirements of the Stipulation.
3. Paragraph 10 of said Stipulation provides that the Board may entertain a motion to modify or terminate the Stipulation, provided certain requirements were met and Licensee did not violate any of the terms of the Stipulation. Licensee met said requirements and fully complied with the Stipulation.

4. On January 29, 1996, Licensee gave notice of his intent to petition the Board for termination of the Stipulation, and submitted his Petition for Termination of Stipulation and Removal of All Restrictions on License on February 12, 1996.

5. Notice of Conference Hearing setting this matter for hearing at 11:00 a.m. on February 17, 1996 was filed herein on February 2, 1996 and served on Licensee and his counsel on that same date.

6. Counsel for the Board does not oppose the termination of said Stipulation, and such termination is supported by the Kansas Medical Society.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that any and all restrictions and limitations placed on Licensee's license to practice medicine and surgery in the State of Kansas by the Stipulation and Agreement and Enforcement Order filed February 27, 1995 and Order Modifying Stipulation and Agreement and Enforcement Order of September 5, 1995 should be terminated and be of no further force or effect.

IT IS SO ORDERED.


