JOURNAL ENTRY AND ORDER TERMINATING STIPULATION

NOW ON THIS 27th day of June, 1997, comes for conference hearing before the Board of Healing Arts ("Board") the request of Linda C. Jackson, P.T. ("Registrant") for termination of the Stipulation and Agreement and Enforcement Order ("Stipulation") of October 29, 1996 between Registrant and the Board. Kevin K. LaChance, Disciplinary Counsel, appears on behalf of the Board. Registrant appears in person.

After hearing statements from the parties and being duly advised in the premises, the Board makes the following findings of fact, conclusions of law and orders:

- 1. Registrant entered into a Stipulation with the Board on October 29, 1996. The Stipulation provided in part that she would not supervise any physical therapist, physical therapist assistant, or certified physical therapist assistant. Further, the Stipulation required completion of an approved training program in supervisory skills prior to any application to lift the limitation of Registrant's authority to supervise.
- 2. By letter received by the Board on June 2, 1997, Registrant advised the Board she had complied with the terms and conditions of the Stipulation and requested termination of the Stipulation.
- The Board determined it would conditionally grant termination of the Stipulation and Agreement and Enforcement Order, contingent upon the Physical Therapy Examining Committee's approval of the seminar as meeting the criteria established in the Stipulation.

THEREUPON, members of the Physical Therapy Examining Committee notified

Disciplinary Counsel that the course attended by Registrant had been reviewed and that the course
was approved as meeting the criteria established in the Stipulation.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that effective June 27, 1997, all restrictions and limitations placed upon Registrant's registration as a physical therapist in the State of Kansas by the Stipulation and Agreement and Enforcement Order filed on October 29, 1996 are terminated.

IT IS SO ORDERED.
