FINAL ORDER

NOW ON THIS 2nd day of March, 2009, the above-entitled matter comes on before John (Jack) Confer, Executive Director of the Kansas State Board of Healing Arts. After reviewing the file and being duly advised in the premises, the Executive Director makes the following determinations.

1. On February 5, 2009, the Executive Director issued a Summary Order regarding the license of Brandon M. Jahnke, M.D. ("Licensee") to practice as a medical doctor in the state of Kansas. The Summary Order contained a provision assessing a \$500 civil fine against Licensee, due and payable on or before March 6, 2009.

2. The Summary Order contained a notice that a written request for hearing could be filed within 15 days following service, but if no hearing is requested, the Summary Order would be come effective as a final order of the Board upon expiration of the time for requesting a hearing.

3. No hearing has been requested by any party; therefore the Summary Order became effective as a final order on February 24, 2009.





SUMMARY ORDER

NOW ON THIS 5th day of February, 2009, this matter comes before John (Jack) Confer, Executive Director, Kansas State Board of Healing Arts ("Board"), in summary proceedings pursuant to K.S.A. 77-537. This Summary Order shall become effective as a Final Order, without further notice, upon the expiration of the fifteen (15) day period if no request for hearing is made, pursuant to K.S.A. 77-542.

Upon review of the agency record and being duly advised in the premises, the following findings of fact, conclusions of law and order are made for and on behalf of the Board:

Findings of Fact

1. Brandon M. Jahnke, M.D. ("Licensee") was originally issued license number 04-30833 to practice medicine and surgery in the state of Kansas on August 14, 2004. Licensee's license is active, having last been renewed on or about July 1, 2008.
2. Licensee's last known mailing address as provided to the Board at the time of his renewal is 1460 Road 315, Clay Center, Kansas 68933.
3. On or about July 1, 2007, Licensee's license expired for failure to renew. On September 30, 2007, Board staff received Licensee's application for reinstatement of his license.
4. On October 3, 2007 the licensing department of the Board sent a letter to Licensee

requesting additional information in regards to his request for reinstatement. Specifically, the licensing department requested that Licensee complete a Reinstatement of Cancelled License form.

5. On November 7, 2007, a second notice to complete the Reinstatement of Cancelled License was sent to Licensee. On December 7, 2007, licensing department spoke to Licensee who stated he mailed the form on December 6, 2007. The form was never received.

6. On May 13, 2008, Board investigator mailed a letter and a third copy of the Reinstatement of Cancelled License form to Licensee for him to complete. This letter was sent certified and was signed for on May 23, 2008 by Amy Jahnke.

7. On June 26, 2008, Board investigator received the completed form from Licensee.

8. On July 15, 2008, a second letter was sent to Licensee by Board investigator. This letter was also certified and signed for by Amy Jahnke on July 17, 2008. This letter requested Licensee to further explain his comments “not working in Kansas at the time”. Licensee was to provide a written response by July 25, 2008. Licensee’s written response was not received until August 11, 2008.

9. All pending investigation materials regarding Licensee were fully reviewed and considered by the Board members who serve on the Board’s Disciplinary Panel. The Disciplinary Panel authorized and directed the issuance of this Summary Order and the specific disciplinary sanctions pursuant to Board Guidelines.

Applicable Law

10. K.S.A. 65-2836 states, in pertinent part: A licensee’s license may be revoked, suspended, or limited or the licensee may be publicly or privately censured, or an application for license or for reinstatement of a license may be denied upon finding of the existence of any of the following grounds:

- (r) The licensee has failed to furnish the board, or its investigators or representatives, any information legally requested by the board.

Conclusions of Law

11. The Board has jurisdiction over Licensee as well as the subject matter of this proceeding, and such proceeding is held in the public interest.

12. The Board finds that Licensee violated K.S.A. 65-2836(r) by failing to provide any information legally requested by the board.

13. Based on the facts and circumstances set forth herein, it appears that the use of summary proceedings in this matter is appropriate, in accordance with the provisions set forth in K.S.A. 77-537(a), in that the use of summary proceedings does not violate any provision of the law and the protection of the public interest does not require the Board to give notice and opportunity to participate to persons other than Licensee, Brandon M. Jahnke, M.D.

IT IS, THEREFORE, ORDERED that Licensee is hereby fined \$500.00. Such fine is payable in full to the “Kansas Board of Healing Arts” on or before March 6, 2009.

NOTICE AND OPPORTUNITY FOR HEARING

PLEASE TAKE NOTICE that this is a Summary Order. A party to whom a Summary Order is issued may file a written request for a hearing pursuant to K.S.A. 77-542 within 15 days following service of the Summary Order. Such written request shall also state the legal and/or factual basis upon which the party opposes this Order. If a hearing is not requested, the Summary Order shall become effective as a Final Order of the Board upon expiration of the time for requesting a hearing. A written request for hearing must be addressed and mailed to Jack Confer, Executive Director, Kansas State Board of Healing Arts, 235 S. Topeka Blvd., Topeka, KS 66603.

PLEASE TAKE NOTICE that upon becoming effective as a Final Order, this document shall be deemed a public record and be reported to any reporting entities authorized to receive such disclosure.


