SUMMARY ORDER

NOW on this 7th day of August, 1993, this matter comes on before the Kansas State Board of Healing Arts (hereinafter referred to as "Board") sitting as a whole as Presiding Officer in a summary proceeding pursuant to the provisions of K.S.A. 77-537 through 77-541, the Application for License by Endorsement filed by Kurisummootil S. James, M.D. (hereinafter referred to as "Applicant") to practice medicine and surgery in the State of Kansas.

Charlene K. Abbott, Licensing Administrator, appears before and on behalf of the Board. Applicant appears not.

After reviewing the application and being duly advised in the premises, the Board finds as follows:

1. On November 19, 1992, Applicant filed an Application for Endorsement to obtain a permanent license to practice medicine and surgery in the State of Kansas.

2. As part of that application, Applicant provided information and documentation regarding postgraduate training which had been obtained by Applicant outside of the United States.

3. At its meeting held December 11 and 12, 1992, the Board reviewed the application and determined that it was incomplete in so far as the documentation which had been provided by Applicant did not show that the postgraduate training Applicant had obtained, although more than three years in length, was equivalent to having obtained one year of postgraduate training in the United States.

4. At the meeting held December 11 and 12, 1992, the Board authorized the granting to Applicant of an Institutional License under the provisions of K.S.A. 65-2895, but tabled action on Applicant's Application for Endorsement for permanent license to practice medicine and surgery to enable Applicant to obtain and submit additional documentation showing the equivalency of postgraduate training to 1 year of such training in the United States.

5. That from and since the action taken by the Board at its meeting December 11 and 12, 1992, Applicant has provided additional information in support of his application.

6. That from the additional information provided, it appears that the postgraduate training obtained by Applicant was equivalent to at least one year of such training had it been obtained in the United States and that Applicant's application is complete and should be granted.

IT IS THEREFORE ORDERED as follows:

a) That the findings here and above made be in the same are made the Order of the Board.

b) Applicant's Application for License by Endorsement is deemed complete and Applicant should be placed on the list for consideration for licensure which will be considered by the Board at its meeting to be held October 9, 1993.

c) That prior to the Board taking action on Applicant's license at its meeting on October 9, 1993, Applicant may apply for and receive a temporary permit under the provision of K.S.A. 65-2811(a)(1) by submitting to the Board the \$30 fee for such temporary permit.

d) Either party is entitled to an administrative review of this Order if written request is received in the Board office within fifteen (15) days of service of this Order upon the parties.

IT IS SO ORDERED.
