FINAL ORDER FOLLOWING CONFERENCE HEARING

NOW, on this 16th day of April, 1994, this matter comes on for consideration before the Kansas State Board of Healing Arts ("Board") sitting as a whole as Presiding Officer in a conference proceeding pursuant to the provisions of K.S.A. 77-533 through 77-535, the application for licensure to practice medicine and surgery in the State of Kansas filed by Urmila Jhaveri, M.D. ("Applicant").

Charlene K. Abbott, Licensing Administrator, appeared for the Board. Applicant did not appear. After reviewing the application and being otherwise duly advised in the premises, the Board finds as follows:

1. On December 14, 1993, Applicant filed an Application for Endorsement to practice medicine and surgery in the State of Kansas.

2. As part of that application, Applicant provided information relating to the examination required for licensure as

set forth in K.S.A. 65-2873(a)(1) and (3) which information indicated that Applicant had taken the three part FLEX examination administered prior to 1985, but did not pass all three parts of said examination at a single administration.

3. Based upon the information provided, Applicant obtained Confidential of the examination when it was administered June, 1977 and received Confidential Confidential when the examination was administered in December, 1977.

4. That while Applicant did not obtain a weighted Confidential in all three parts in one sitting, the scores that Applicant received on Parts 1 and 3 administered in December, 1977 together with the score received on Part 2 administered in June, 1977 would, if combined, provide a FLEX weighted average of at Confidential

5. That the scores obtained on the FLEX examination should be accepted and Applicant is eligible to receive a license by endorsement at such time as the application is deemed complete.

IT IS THEREFORE ORDERED that the findings here and above made be and the same are made the order of the Board and Applicant is eligible for licensure by endorsement based upon the examination scores above recited.

IT IS FURTHER ORDERED that Applicant shall not receive a license to practice medicine and surgery in the State of Kansas until such time as all requirements of the application have been met.

IT IS FURTHER ORDERED that this is a Final Order and is effective upon service upon the parties. Any party may, within fifteen (15) days after service, file a Petition for Reconsideration. The filing of a Petition for Reconsideration is not a prerequisite for seeking administrative or judicial review.

IT IS SO ORDERED.
