**JOURNAL ENTRY OF SATISFACTION**

COMES NOW the Kansas State Board of Healing Arts (“Board”), by and through its Executive Director, Kathleen Selzler Lippert, a duly authorized representative of the Board, in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501 *et seq.*, as amended, and upon due consideration of the agency record and applicable statutes and regulations, and being otherwise duly advised in the premises, makes the following determinations:

1. On or about June 17, 2015, Kirk C. Johnson, D.C. (“Licensee”) entered into a Consent Order with the Board for alleged violations of the Kansas Healing Arts Act, K.S.A. 65-2801, *et seq.* The Consent Order required Licensee to a fine in the amount of \$2,000.00.
2. Further, the Consent Order required Licensee to attend and successfully complete a documentation program that included the post-program feedback.
3. On or about December 14, 2015, Licensee submitted to the Board documentation evidencing completion of the Medical Record Keeping Seminar offered by the Center for Personalized Education for Physicians (“CPEP”).
4. On or about June 6, 2016, Licensee submitted to the Board documentation evidencing completion of the post-program feedback Personalized Implementation Program offered by CPEP.

5. On or about June 14, 2016, Licensee remitted full payment of the fine to the Kansas State Board of Healing Arts.

6. Licensee has satisfactorily met all requirements of the Consent Order and has no further obligation for compliance.

**IT IS THEREFORE ORDERED** that Licensee is hereby discharged from all requirements of the Consent Order filed on June 17, 2015.

**IT IS FURTHER ORDERED** that Licensee's probation is hereby terminated.
