ORDER OF RETROACTIVE REINSTATEMENT OF REGISTRATION

NOW on this 27th day of June, 1997, comes on for consideration before the Kansas State Board of Healing Arts (hereafter "Board"), sitting as a whole in a conference proceeding, the Application for Reinstatement of Wendell K. Johnson, R.T., (hereafter "Applicant") for reinstatement of active registration as a respiratory therapist.

Charlene K. Abbott, Licensing Administrator, presented information to the Board. Applicant appears in person pro se.

After reviewing the request and being otherwise duly advised in the premises, the Board finds as follows:

1. Applicant was originally issued registration number 16-00846 as a respiratory therapist on June 17, 1988, which was cancelled for non-renewal on February 1, 1989.

2. Applicant's Application for Registration was received by the Board on January 13, 1997 and referred to the Respiratory Therapy Council for recommendation of a program of continuing education under K.A.R. 100-55-8(a)(3).

3. The Respiratory Therapy Council made certain recommendations regarding a program of continuing education and Applicant has provided evidence of satisfactorily meeting the recommended requirement.

4. During conference proceedings on this matter, Applicant requested that the Board retroactively reinstate his registration to practice respiratory therapy to May 11, 1995.

5. There are insufficient reasons to deny Applicant's application for reinstatement.

IT IS THEREFORE BY THE BOARD ORDERED as follows:


a. That the findings here and above made be and the same are made the order of the Board.

b. That registration number 16-00846 issued to Wendell K. Johnson, R.T., cancelled on February 1, 1989, be retroactively reinstated to January 13, 1997 to reflect that Applicant continuously held a current registration from and since January 13, 1997.

c. This is a Final Order and is effective upon service upon the parties. Any party may, within fifteen (15) days after service, file a Petition for Reconsideration. The filing of a Petition for Reconsideration is not a prerequisite for seeking administrative or judicial review.
