#### FINAL ORDER FOLLOWING CONFERENCE HEARING

**NOW**, on this 5th day of April, 1997, this matter comes on for consideration before the Kansas State Board of Healing Arts (hereafter "Board"), sitting as a whole as Presiding Officer in a conference proceeding pursuant to the provisions of K.S.A. 77-533, the request of Michael Jerome Johnson, M.D. (hereafter "Licensee") for retroactive reinstatement of license.

Charlene Abbott, Licensing Administrator presented information before the Board. Licensee appeared pro se.

After hearing statements of the parties and being otherwise duly advised in the premises, the Board finds as follows:

 Licensee failed to renew license number 4-24693 which was originally issued on August 7, 1993 and said license was subsequently cancelled August 1, 1996 pursuant to K.S.A. 65-2809 and amendments thereto.

2) Pursuant to Board records, Licensee applied for and received reinstatement of his license on December 18, 1996.

3) Applicant has worked exclusively in a residency program from the time of cancelation of his license to the date of reinstatement of said license.

4) Licensee requested the Board retroactively reinstate his license to practice medicine and surgery from August 1, 1996 until the date of reinstatement, December 18, 1996.

5) Licensee advised the Board that he had mailed his renewal form to the Board office, but the Board could find no record of receiving the renewal. Licensee further indicated that his check for license renewal was never presented to his bank for payment.

## IT IS THEREFORE BY THE BOARD ORDERED as follows:

A. That the findings here and above made be and the same are made the Order of the Board.

B. That license number 4-24693 issued to Licensee which was cancelled on August 1, 1996 and reinstated on December 18, 1996, be retroactively reinstated to August 1, 1996 and that the records of the Board be amended to reflect that Licensee has continuously held a current license from and since August 7, 1993.

C. This is a Final Order and is effective upon service upon the parties. Any party may, within fifteen (15) days after service, file a Petition for Reconsideration. The filing of a Petition for Reconsideration is not a prerequisite for seeking administrative or judicial review.
