### JOURNAL ENTRY OF SATISFACTION OF REQUIREMENTS OF FINAL ORDER

**NOW**, on this 261 day of April 2009, this matter comes before John (Jack) Confer, Executive Director, Kansas State Board of Healing Arts ("Board"), concerning Licensee's satisfaction of all requirements contained in the Final Order which was filed on April 13, 2009. Wherefore the Board finds as follows:

1. On or about April 13, 2009, the Board issued a Final Order regarding the license of Anita Johnson, LRT ("Licensee") to practice as a Radiologic Technologist in the state of Kansas. The Final Order contained a provision for Licensee to pay a fine in the amount of \$250 on or before March 9<sup>th</sup>. The Final Order became effective March 2, 2009.

2. Licensee paid the \$250 fine on April 13, 2009

3. On or about April 13, 2009, the Board issued a Final Order regarding the license of Anita Johnson, LRT ("Licensee") to practice as a Radiologic Technologist in the state of Kansas. The Final Order contained a provision for the Licensee to submit proof of 24 hours of continuing education by May 9, 2009. The Final Order became effective March 2, 2009.

4. Licensee submitted proof of 24 hours continuing education on March 30, 2009

5. Licensee has satisfied all requirements of the Final Order and has no further obligation for compliance.



#### FINAL ORDER

**NOW,** on this <u>IS</u> day of April 2009, this matter comes before John (Jack) Confer, Executive Director of the Kansas State Board of Healing Arts. After reviewing the file and being advised in the premises, the Executive Director makes the following determinations.

1. On February 9, 2009 the Executive Director issued a Summary Order regarding the license of Anita Johnson, LRT ("Licensee") to practice as a Radiologic Technologist in the state of Kansas. The Summary Order contained a provision assessing a \$250 civil fine against Licensee, due payable on or before March 9, 2009

2. On February 9, 2009 the Executive Director issued a Summary Order regarding the license of Anita Johnson, LRT ("Licensee") to practice as a Radiologic Technologist in the state of Kansas. The Summary Order contained a provision for the Licensee to complete 24 hours of continuing education, due on or before May 9, 2009

3. The Summary Order contained a notice that a written request for hearing could be filed within 15 days following service, but if no hearing is requested, the Summary Order would be come effective as a Final Order of the Board upon expiration of the time for the requesting a hearing.

4. No hearing has been requested by any party; therefore the Summary Order became effective as a final order on March 2, 2009

# **SUMMARY ORDER**

**NOW ON THIS** day of February, 2009, this matter comes before Jack Confer,

Executive Director, Kansas State Board of Healing Arts ("Board"), in summary proceedings pursuant to K.S.A. 77-537.

After reviewing the agency record and being duly advised in the premises, the following findings of fact, conclusions of law and order are made for and on behalf of the Board:

1. Anita Johnson, LRT ("Licensee") was originally issued license number 22-02310 to practice as a Radiologic Technologist in the State of Kansas on December 28, 2005.

2. On or about September 30, 2008, Licensee submitted an application for renewal of their license.

3. Pursuant to K.S.A. 65-7307 and K.A.R. 100-73-7 each Licensee desiring to renew a Radiologic Technologist license must have completed at least 12 credits of continuing education and to provide proof of completion to the Board upon request

4. As part of the renewal process, Licensee certified that the rules regarding continuing education had been read, that compliance had been achieved, and that documentation of the continuing education would be maintained for a three-year period and produced to the Board upon request.

5. Licensee was randomly selected to provide verification of compliance with the continuing requirements and on November 14, 2008, a letter was mailed to Licensee requesting that Licensee provide no later than December 31, 2008, the records relied upon when Licensee certified achievement of the required continuing education.

6. On November 19, 2008, Licensee submitted information for a class that she had taken and a copy of her BLS CPR Card.

7. On November 20, 2008 the board sent a letter to the Licensee requesting that a copy of the certificate for the course taken be submitted by December 31, 2008.

8. On January 7, 2009 the board sent a letter again requesting that a copy of the certificate for the coarse taken be submitted and informing her that BLS CPR was not approved continuing education hours and that this information needed submitted by January 23, 2009.

9. Licensee failed to provide documented evidence of 12 hours of continuing education since April 1, 2007

10. By failing to provide documented evidence of continuing education, Licensee has violated K.S.A. 65-7307(c), failing to provide evidence of satisfactory completion of 12 hours of continuing education.

11. In addition to any other penalty prescribed under the Radiologic Technologist Practice Act, K.S.A. 65-7313 and K.S.A. 65-2836a authorizes the Board to assess an administrative fine in an amount not exceeding \$5,000 for the first violation of the Radiologic Technologist Practice Act.

**IT IS, THEREFORE, ORDERED** Licensee is hereby fined \$250 for failure to respond to the Board's legal request for information. The fine is due within thirty days of the effective date of this order.

**IT IS FURTHER ORDERED** that licensee shall submit proof of the continuing education requirements for the previous year to the Board with fifteen days following service of this summary order.

**PLEASE TAKE NOTICE** that this is a summary order. A party to whom a summary order is issued may file a written request for a hearing within 15 days following service of the summary order. If a hearing is not requested, the summary order shall become effective as a final order of the Board upon expiration of the time for requesting a hearing. A request for a hearing must be addressed to Jack Confer, Executive Director, 235 South Topeka Boulevard, Topeka, Kansas 66603.
