NOW on this 29th day of November 2011, this matter comes before Kathleen Selzler Lippert, Executive Director, Kansas State Board of Healing Arts ("Board"), in regard to Licensee's satisfaction of the confidential monitoring provisions contained in the Final Order Following Conference Hearing filed on June 14, 2007.

Wherefore, the Board finds as follows:

1. On or about February 12, 2007, Licensee entered into a Consent Order with the Board limiting Licensee's status to inactive status, and further ordered that in considering a petition by Licensee to change the status of license back to active, the Board may evaluate the recommendations confidential

2. On or about May 21, 2007, the Board received Licensee's request to apply for reinstatement of his Kansas Physician Assistant license to an active designation.

3. On or about June 8, 2007, Licensee entered into a monitoring contract confidential
confidential for a period of four (4) years.

4. On or about June 14, 2007, a Final Order Following Conference Hearing granted Licensee's request for reinstatement of his license back to active designation, and further required Licensee to comply with all terms and conditions of his monitoring contract with confidential

5. On or about October 31, 2011, ^{confidential} notified the Board that Licensee was compliant with all of their requirements and successfully completed his monitoring contract on June 8, 2011.


6. Licensee has satisfactorily met all requirements of the ^{confidential} monitoring contract and has no further obligation for compliance.

IT IS THEREFORE ORDERED that Licensee is hereby discharged from all requirements of the Final Order Following Conference Hearing filed on June 14, 2007.


IT IS SO ORDERED.


