
1. On May 27, 2008, the Executive Director, on behalf of the Board, issued a Summary Order under Policy 08-03 in which it was determined that Scott Lawrence Jones, PT license should be suspended on the effective date of this order for failure to provide the Board with requested documentation.

2. The Summary Order contained a notice that a written request for hearing could be filed within 15 days following service, but if no hearing is requested, the Summary Order would become effective as a final order of the Board upon expiration of the time for requesting a hearing.

3. No hearing has been requested by any party and, therefore, the Summary Order became effective on June 17, 2008; and as stated in the Summary Order the license will be suspended on the effective date.



**JOURNAL ENTRY OF SATISFACTION VACATING SUSPENSION OF
LICENSE**

NOW, on this 21st day of January, 2009, the above-entitled matter comes on before Jack Confer, Executive Director of the Kansas State Board of Healing Arts. After reviewing the file and being duly advised in the premises, the Executive Director makes the following determinations.

1. On May 27, 2008, A Summary Order was filed in Docket No. 08-HA00212 which found that Licensee had violated K.S.A. 65-2912(a)(5) and K.A.R. 100-29-12(7) by failing to furnish to the board any information legally requested by the board. The Summary Order stated that failure to comply with the terms of the Order would result in the suspension of the license to practice physical therapy in Kansas. Licensee failed to comply with the terms of the order.


2. On June 19, 2008, the license of Scott Lawrence Jones, PT (licensee) was suspended for failure to provide documented evidence of professional liability insurance coverage.

3. On January 20, 2009, licensee provided documented proof of professional liability insurance coverage for the requested period.

4. Licensee has fully satisfied the requirements set forth in the Summary Order filed May 27, 2008 by providing documentation of professional liability insurance coverage; therefore the Suspension of License imposed by the Summary Order filed May 27, 2008 is lifted, and no further action is required.
