REINSTATEMENT OF POSTGRADUATE PERMIT**

NOW ON THIS 7TH of June, 2003, comes on for consideration before the Kansas State Board of Healing Arts (hereafter "Board"), sitting as a whole as Presiding Officer in a Conference Proceeding pursuant to the provisions of K.S.A. 77-533, the request of Haidar Kabbani, M.D. (hereafter "Petitioner") for retroactive reinstatement of postgraduate permit. Charlene Abbott, Licensing Administrator, presents information to the Board. Petitioner appears in person. Pam Shaw, Residency Director of the Pediatrics Department of the University of Kansas Medical Center also appeared.

After hearing statements of the parties and being duly advised in the premises, the Board finds as follows:

1. Petitioner submitted an application for a postgraduate permit for the Department of Neurology at Kansas University Medical Center indicating the program would begin November 1, 1998 and be completed October 3, 2001.
2. Petitioner was issued postgraduate permit number 94-05006, effective November 1, 1998 to expire October 31, 2001. At the time this permit was issued, Kansas law provided for three-year permits.
3. Petitioner was issued a second postgraduate permit November 1, 2001 through October 31, 2002.
4. Petitioner completed the application for a third postgraduate permit and turned it into the department of Pediatrics. The Pediatrics department personnel did not forward the application to the Board in a timely manner. Petitioner was unaware

that the application was not forwarded to the Board office.


5. On May 5, 2003 the Board received Petitioner's application which was granted May 12, 2003. His Affidavit from the department of Pediatrics indicated he was beginning pediatrics residency November 1, 2002 through October 31, 2003.
6. Petitioner is requesting retroactive reinstatement of his permit from November 1, 2002 to May 12, 2003
7. The Board finds sufficient cause exists to grant Petitioner retroactive reinstatement of postgraduate permit from November 1, 2002 through October 31, 2003.

IT IS THEREFORE ORDERED AS FOLLOWS:

1. That the findings here and above made be and the same are made the order of the Board.
2. That postgraduate permit number 94-05006 of Haidar Kabbani, M.D. to practice medicine and surgery in the State of Kansas originally issued November 1, 1998, and which expired November 1, 2002, and was reinstated on May 12, 2003, be made effective retroactively from and after November 1, 2002. This permit will expire October 31, 2003.

IT IS SO ORDERED.
