**FINAL ORDER GRANTING WITHDRAWAL OF APPLICATION**

COMES NOW the Kansas State Board of Healing Arts (“Board”), by and through its Executive Director, Kathleen Selzler Lippert, a duly authorized representative of the Board, in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501 *et seq.*, as amended, and upon due consideration of the agency record and applicable statutes and regulations, and being otherwise duly advised in the premises, makes the following determinations:


1. On or about March 29, 2013, Dane S. Kelley (“Applicant”) submitted to the Board an application for certification to practice as a physical therapist assistant. Such application was filed with the Board on July 16, 2013.
2. The Board is the sole and exclusive administrative agency in the State of Kansas authorized to regulate the practice of the healing arts, specifically the practice of physical therapy. K.S.A. 65-2901 *et seq.*
3. Applicant appeared before the Board for the presentation of a Consent Order for licensure on August 9, 2013.
4. Due to questions about the Consent Order’s terms, the matter was continued and a presiding officer was appointed to hear a later presentation of the Consent Order.

5. On September 4, 2013, Applicant submitted a request to the Board to withdraw his application for licensure. Associate Litigation Counsel for the Board does not object to Applicant withdrawing his application for licensure.

6. The Board accepts withdrawal of Applicant's application.

**IT IS THEREFORE ORDERED, BY THE KANSAS STATE BOARD OF HEALING ARTS,** that Applicant's request to withdraw his application for licensure to practice as a physical therapist assistant in the State of Kansas is hereby **GRANTED.**


