FINAL ORDER

NOW this October 11, 2008 the above captioned matter comes before the Board of Healing Arts of the State of Kansas (Board) on the applicant's motion to waive professional school verification from the Aga Khan University in Karachi, Pakistan as a condition for receiving license to practice medicine and surgery. The applicant appears in person *pro se*. The Board appears by Dan Riley, Disciplinary Counsel. There are no other appearances.

The Board having reviewed the record and being fully apprised of the circumstances makes the following findings of fact:


1. The applicant, Emma Khan, M.D., has applied to the Board seeking a license to practice medicine and surgery.
2. The applicant currently possesses a postgraduate permit to practice medicine and surgery in Kansas and Missouri.
3. The applicant has completed all requirements for a license to practice medicine and surgery in Kansas, except for obtaining a professional school certification from the Aga Khan University.
4. The applicant has provided her original transcript and original diploma from the Aga Khan University to Board staff as evidence of the fact she

has graduated from that university. Verified copies of those documents have been submitted to the Board.

WHEREFORE, the Board grants the applicant a waiver from obtaining professional school certification from the Aga Khan University.

PLEASE TAKE NOTICE that this is a final order. A final order is effective upon service. A party to an agency proceeding may seek judicial review of a final order by filing a petition in the District Court as authorized by K.S.A. 77-601, et seq. Reconsideration of a final order is not a prerequisite to judicial review. A petition for judicial review is not timely unless filed within 30 days following service of the final order. A copy of any petition for judicial review must be served upon Jack Confer, the Board's Acting Executive Director, at 235 SW Topeka Blvd., Topeka, KS 66603.


