FINAL ORDER ON GRANTING LICENSURE BY ENDORSEMENT

COMES NOW the Kansas State Board of Healing Arts (“Board”), by and through its Executive Director, Kathleen Selzler Lippert, a duly authorized representative of the Board, in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501 *et seq.*, as amended, and upon due consideration of the agency record and applicable statutes and regulations, and being otherwise duly advised in the premises, makes the following determinations:

1. On or about August 22, 2011, Applicant submitted an application for licensure by endorsement for an active license to practice medicine and surgery in the State of Kansas. Such application was deemed complete and filed with the Board on January 25, 2012.
2. On January 26, 2012, Associate Litigation Counsel filed a Response to Application for Licensure by Endorsement.
3. On February 24, 2012, a conference hearing on Applicant’s application was held before the Board in which the Board considered and denied Applicant’s application. A Final Order Denying Licensure by Endorsement was issued on March 22, 2012, based on a lack of evidence that Applicant has satisfactorily fulfilled the requirements of K.S.A. 65-2833.
4. On or about March 31, 2012, Applicant was issued License No. ME112555 in the State of Florida for the profession of “Medical Doctor.”

5. On or about April 2, 2012, Applicant made a timely request pursuant to K.S.A. 77-529 for reconsideration of the Final Order Denying Licensure by Endorsement. Applicant's request noted that he had been "actively practicing medicine since 1997, including 10 years of residency (Korea) and Fellowship (USA)." Additionally, Applicant submitted evidence that he was recently granted a full, unrestricted medical license in the State of Florida.

6. A conference hearing on Applicant's request for reconsideration was held before the full Board on April 13, 2012. Subsequent to the conference hearing, the Board issued a Final Order on Reconsideration Granting Licensure by Endorsement Upon Meeting Condition. The Final Order vacated the previous denial and found that Applicant had passed the Clinical Radiation Oncology examination in January of 2012, and that passage of the 2012 oral examination for board certification by the American Board of Radiology would provide sufficient evidence that Applicant meets the Kansas qualifications for licensure. The Final Order further provided that if Applicant did not provide the Board with official documentation of passage by July 1, 2012, the application would be denied.

7. On July 10, 2012, a Journal Entry Denying Licensure was issued based on Applicant's failure to pass all categories of the 2012 oral examination.

8. On or about July 11, 2012, Applicant requested reconsideration of the Journal Entry Denying Licensure.

9. A conference hearing on Applicant's request for reconsideration was held before the full Board on August 17, 2012. At the conference hearing, the Board indicated their willingness to accept Applicant's withdrawal of application in lieu of denial.

10. On August 20, 2012, Applicant requested withdrawal of his application.


11. On August 29, 2012, the Board issued a Final Order Accepting Withdrawal of Application.

12. On or about June 11, 2013, Applicant passed the remaining categories of the oral examination for board-certification by the American Board of Radiology. Applicant is presently board-certified in radiology.

13. Based upon Applicant's board-certification by the American Board of Radiology, the Board concludes that Applicant has now demonstrated qualification for licensure in Kansas and that such license should be granted upon Applicant's satisfactory completion of all requirements to update his prior application for licensure by endorsement.

IT IS THEREFORE ORDERED, BY THE KANSAS STATE BOARD OF HEALING ARTS that upon satisfactory completion of all requirements to update his prior application for licensure by endorsement, Applicant shall be GRANTED a license to practice medicine and surgery in Kansas
