FINAL ORDER ACCEPTING WITHDRAWAL OF APPLICATION

NOW on this the 17th day of August, 2012, comes before the Kansas State Board of Healing Arts ("Board"), the request of Whoon Jong Kil, M.D. ("Applicant") for reconsideration of the Journal Entry Denying Licensure. Applicant appears *pro se*. Brandy Snead, Associate Litigation Counsel, appears for the Respondent Board.

Pursuant to the authority granted to the Board, in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501 *et seq.*, as amended, and pursuant to the authority granted to Board by K.S.A. 65-2801 *et seq.*, as amended, the Board hereby enters this Final Order following a conference hearing in the above-captioned matter. After reviewing the file, hearing the testimony and arguments of the parties, and being otherwise duly advised in the premises, the Board makes the following findings, conclusions and order:

- 1. On or about August 22, 2011, Whoon Jong Kil, M.D. ("Applicant") submitted an application to the Board for licensure by endorsement to practice medicine and surgery in the State of Kansas. Such application was deemed completed and filed with the Board on January 24, 2012.
- 2. Upon consideration at a February 24, 2012 conference hearing, the Board issued its Final Order on March 22, 2012, denying Applicant's application for licensure by endorsement due to lack of evidence that Applicant satisfactorily fulfilled the requirements of K.S.A. 65-2833.

3. On or about April 2, 2012, Applicant submitted additional evidence and made a

timely request pursuant to K.S.A. 77-529 for reconsideration of the Board's Final Order denying

Applicant licensure by endorsement.

4. At an April 13, 2012 conference hearing on reconsideration, the Board found that

Applicant passed the clinical Radiation Oncology board-certification examination in January

2012, and further, that passage of the 2012 oral Radiation Oncology examination for board-

certification by the American Board of Radiology would provide sufficient evidence that

Applicant met the Kansas qualifications for licensure.

5. On or About May 14, 2012, the Board issued a Final Order on Reconsideration,

granting Applicant a license by endorsement contingent upon Applicant providing the Board on

or before July 1, 2012, with official documentation verifying his passage of the oral examination

for board-certification in Radiation Oncology by the American Board of Radiology.

6. On or about June 14, 2012, the American Board of Radiology issued its report of

Applicant's Radiation Oncology oral examination results, which indicated Applicant failed in

two (2) categories, and therefore, required reexamination in each category failed.

7. On or about July 10, 2012, the Board issued a Journal Entry Denying Licensure to

Applicant pursuant to the terms of the Board's Final Order of May 14, 2012.

8. On or about July 11, 2012, Applicant requested the Board reconsider its July 10,

2012 Journal Entry Denying Licensure.

9. Upon presentation of evidence by both parties at the conference hearing on

reconsideration, Applicant accepted the Board's offer to allow him to request withdrawal of his

application for licensure by endorsement as long as such request was made within five days of

hearing.

- 10. On or about August 20, 2012, Applicant submitted for filing with the Board, his request to withdraw his application for licensure by endorsement to practice medicine and surgery in the State of Kansas.
 - 11. The Board finds that withdrawal of Applicant's application is acceptable.

IT IS THEREFORE ORDERED, BY THE KANSAS STATE BOARD OF HEALING ARTS, that Applicant's request to withdraw from consideration his application for licensure by endorsement to practice medicine and surgery in the State of Kansas is hereby accepted.
