#### FINAL ORDER FOLLOWING CONFERENCE HEARING

NOW ON THIS Eighteenth Day of October, 2003, comes before the Kansas Board of Healing Arts an Application for Physician's Assistant License of Nancy L. Kisner (hereafter "Applicant"). Petitioner appears through Kelli J. Benintendi, Associate Counsel. Respondent appears in person and without counsel.

This matter is commenced as a conference hearing under the Kansas administrative procedure act. After hearing testimony of Respondent and being fully advised, the Board makes the following findings of fact, conclusions of law and order:

1. Applicant came before the Board at the December, 2001 meeting in response to a disciplinary petition against her respiratory therapy license. The Board issued a *Final Order* on December 13, 2001 suspending Applicant's license as a Respiratory Therapist and required Applicant, among other things, to appear before the Board prior to being granted a physician's assistant license.

2. Applicant's suspension was terminated by *Final Order* issued March 8, 2002 where Applicant was also required to continue (**Confidential**) until the end of July, 2002, and to submit monthly reports (**Confidential**) 3. Applicant has fulfilled the requirements placed upon her by the Board in the *Final Order* dated December 13, 2001.

4. The Board is satisfied that Applicant has demonstrated she is qualified for licensure as a Physician's Assistant.

5. The Board agrees that upon passing the required exams and upon completion of all other requirements for licensure, the Board should grant Applicant a Physician's Assistant license without limitations or restrictions.

6. This is a Final Order. A Final Order is effective upon service. A party may seek review of a Final Order by filing a petition with the District Court within 30 days following service of the order. A copy of such petition must be served upon the Executive Director of the Board. Reconsideration is not a prerequisite to judicial review.
