ORDER OF RETROACTIVE REINSTATEMENT OF REGISTRATION

NOW, on this 27th day of June, 1997, comes on for consideration before the Kansas State Board of Healing Arts (hereafter "Board"), sitting as a whole in a conference proceeding pursuant to the provisions of K.S.A. 77-533 through 77-535, the request of Daniel B. Knaup (hereinafter "Registrant") for retroactive reinstatement of his registration to practice physical therapy in the State of Kansas.

Charlene K. Abbott, Licensing Administrator, presents information to the Kansas Board of Healing Arts. Permittee appears in person *pro se*. Jackie Rawlings, Physical Therapy Examining Committee, was present.

After reviewing the request and being otherwise duly advised in the premise,

ORDER OF RETROACTIVE REINSTATEMENT OF REGISTRATION

the Board finds as follows:

1. Permittee was granted an original registration September 25, 1976 to practice physical therapy in the State of Kansas.
2. On February 1, 1997, Registrant's registration was cancelled for failure to renew.
3. On February 20, 1997, Registrant filed a Renewal of Kansas Physical Therapist Registration with the Board office. At that same time, Registrant requested his registration be retroactively reinstated to February 1, 1997.
4. The failure of Permittee to timely submit the Renewal of Kansas Physical Therapist Registration was due to inadvertence and mistake on the part of Registrant.

IT IS THEREFORE BY THE BOARD ORDERED as follows:


- A. That the findings here and above made be and the same are made the Order of the Board.
- B. That registration number 11-00558 issued to Daniel B. Knaup, P.T. be retroactively reinstated to February 1, 1997.
- C. This is a Final Order and is effective upon service upon the parties. Any party may, within fifteen (15) days after service, file a Petition for Reconsideration. The filing of a Petition for Reconsideration is not a prerequisite

for seeking administrative or judicial review.


