FINAL ORDER FOLLOWING CONFERENCE HEARING

NOW, on this 1st day of June, 2002, comes on for conference hearing before the Kansas State Board of Healing Arts ("Board") the Application for Licensure filed by H. Peter Koenen-Myers, M.D. ("Applicant"). Applicant appears in person. The Board appears by and through Kelli J. Benintendi, Associate Counsel. There are no other appearances.

After hearing the statements of Applicant, the arguments of counsel and having the official agency record before it, the Boards finds, concludes and orders as follows:

1. On December 18, 2001, Applicant filed an Application for Licensure to receive a license to practice medicine and surgery in the state of Kansas.
2. Notice of Conference Hearing on Applicant's Application for Licensure was filed herein on May 15, 2002, setting the application for hearing on Saturday, June 1, 2002, at 10:30 a.m.
3. Under the section entitled "VI. Discipline", Applicant answered "Yes" to questions numbered 10, 11, 13 and 18.
4. Applicant has previously been licensed in California and Arizona. Applicant's California license expired on July 31, 1991, and was thereafter canceled. Applicant's Arizona license expired in May 1995.

5. As part of his application and testimony provided during the hearing, Applicant stated he has not practiced medicine and surgery since 1993.


6. Although Applicant has engaged in numerous continuing education activities since 1993, questions remain as to Applicant's current ability to competently practice with reasonable skill and safety to patients.

7. During the course of the hearing, Applicant requested that he be allowed to withdraw his Application for Licensure until such time as he can engage in additional training and education that would reflect on his current competency to practice. Such request should be granted.

8. The Board recommended to Applicant that, prior to resubmitting another Application for Licensure, he take and pass the Special Purpose Examination (SPEX) as a means to ascertain his current knowledge requisite for the general, undifferentiated practice of medicine. Further, the Board recommended that, following passage of SPEX, he engage in and successfully complete at least one year of approved post-graduate training. Board member Mark A. McCune, M.D. is designated to monitor Applicant's progress during the course of any post-graduate training in which Applicant may be involved. Completion of these recommendations does not imply any subsequent Application for Licensure will be granted by the Board.

IT IS THEREFORE ORDERED that Applicant's request to withdraw his Application for Licensure is granted and no further proceedings are necessary or required.


