**FINAL ORDER FOLLOWING CONFERENCE HEARING**

**NOW**, on this 21st day of June, 2008, comes on for conference hearing before the Kansas State Board of Healing (“Board”) the Request for Termination of Board Consent Order filed by Andrea Komarek, P.A.. (“Licensee”). Licensee appears in person *pro se*. Kathleen Selzler Lippert, Associate Counsel, appears for the Board.

After reviewing the file, hearing the statements of the parties, and being duly advised in the premises, the Board finds, concludes and orders as follows:

1. Licensee agreed to a Consent Order that was approved by the Board and was filed June 12, 2006.
2. In the Consent Order, Licensee agreed to certain monitoring provisions regarding her license to practice as a physician assistant in the state of Kansas.
3. Licensee has been in compliance with the Consent Order.
4. The Consent Order and the monitoring provisions imposed upon Licensee by such Consent Order should be terminated.


**IT IS THEREFORE ORDERED** that Licensee’s Motion to Terminate Board Consent Order should be granted and the Consent Order should have no further force or effect.

**PLEASE TAKE NOTICE** that this is a Final Order. A Final Order is effective upon service. A party to an agency proceeding may seek judicial review of a Final Order

by filing a petition in District Court as authorized under the Kansas Act for Judicial Review and Civil Enforcement of Agency Actions, K.S.A. 77-601 *et seq.* A petition for judicial review is not timely unless filed within 30 days following service of the Final Order. A copy of any such petition must be served upon the Board addressed to the Executive Director, 235 S. Topeka Boulevard, Topeka, Kansas 66603. A request for reconsideration is not a prerequisite to judicial review.


