ORDER DENYING THIRD TEMPORARY REGISTRATION

NOW on this 27th day of April, 1996, this matter comes on for conference proceedings before the Board of Healing Arts (hereafter "Board") at the request of Odongo John K'Omoga (hereinafter "Registrant") to grant a third temporary registration pursuant to K.S.A. 65-5408(d).

Charlene K. Abbott, Licensing Administrator, presents information to the Kansas Board of Healing Arts. There are no other appearances.

After reviewing the file, hearing statements of the parties and being duly advised in the premises, the Board makes the following findings of fact, conclusions of law and orders:

1. A request for third temporary registration was received from Registrant on March 13, 1996.
2. Notice of Conference Hearing setting this matter for hearing at 10:15 a.m. on April 27, 1996, was filed herein on April 11, 1996 and served on Registrant on that same date.
3. Registrant has applied for permanent registration as an occupational therapist, but has not passed an exam approved by the Board as required by K.S.A. 65-5406(a)(3).
4. Registrant was granted temporary registration number 9403068, which expired May 25, 1995. Registrant was subsequently granted second temporary registration number 9620227 to allow him to sit for the AOTCB examination, and said registration expired March 30, 1996.

ORDER DENYING THIRD TEMPORARY REGISTRATION

5. Pursuant to K.S.A. 65-5408(d), not more than one temporary registration shall be permitted to any one person without the majority approval of the members of the Board.

6. The Board finds that insufficient cause exists to grant Registrant a third temporary registration. Applicant may reapply for a third temporary registration once he has passed the required exam, has provided proof as such, and has met all of the requirements for permanent registration as an occupational therapist.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED as follows:

A. That Registrant's request for a third temporary registration is hereby denied.

B. That this is a Final Order and is effective upon service upon the parties. Any party may, within fifteen (15) days after service, file a Petition for Reconsideration. The filing of a Petition for Reconsideration is not a prerequisite for seeking administrative or judicial review.

IT IS SO ORDERED.


