JOURNAL ENTRY OF SATISFACTION

COMES NOW the Kansas State Board of Healing Arts (“Board”), by and through its Executive Director, Kathleen Selzler Lippert, a duly authorized representative of the Board, in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501 *et seq.*, as amended, and upon due consideration of the agency record and applicable statutes and regulations, and being otherwise duly advised in the premises, makes the following determinations:

1. On or about December 23, 2014, Licensee entered into a Consent Order with the Board for alleged violations of the Kansas Podiatry Act, K.S.A. 65-2001, *et seq.* The Consent Order required Licensee attend and successfully complete at least five (5) hours of continuing medical education specifically in the form of bunion treatment and post-op care at a Board-approved program. Further, Licensee was required to complete the Midwest Podiatry Conference on March 3-8, and to provide the Board documentation evidencing completion of same within thirty (30) days of completing this course.

2. On or about December 12, 2014, Licensee submitted to the Board documentation evidencing completion of Complications and Infection Management in Forefoot and Hallux Valgus Surgery, presented by the Podiatry Institute, which Licensee completed on approximately November 6-9, 2014.

3. Additionally, on or about April 2, 2015, Licensee submitted to the Board documentation evidencing completion of the Midwest Podiatry Conference, which Licensee completed on approximately March 3-8, 2015.

4. Licensee has satisfactorily met all requirements of the Consent Order and has no further obligation for compliance.

IT IS THEREFORE ORDERED that Licensee is hereby discharged from all requirements of the Consent Order filed on December 23, 2014.


