**ORDER TERMINATING STIPULATION

NOW ON THIS 17th day of October, 1998, comes for conference hearing before the Board of Healing Arts ("Board") the request of Stephen S. Labash, M.D. (hereinafter "Licensee") that the **Stipulation and Agreement and Enforcement Order**, filed October 22, 1996, be terminated. Due to illness of litigation counsel, Lawrence T. Buening, Jr. presented information to the Board so the Board could proceed. Dr. Labash appeared with counsel, Charles Peckham, Atwood, Kansas.

After examining the files, hearing statements of the parties and being otherwise duly advised, the Board finds as follows:

- 1) A Stipulation and Agreement and Enforcement Order was entered into between Licensee and the Board on October 22, 1996.
- 2) After hearing statements of the parties, the Board is satisfied that the Licensee has been in compliance with the conditions and limitations placed upon his license.
- 3) The **Stipulation and Agreement and Enforcement Order**, filed on October 22,


1996, should be terminated.

NOW, THEREFORE, it is ordered by the Board that the findings hereinabove made be and the same are hereby made the order of the Board; that the **Stipulation and Agreement and Enforcement Order**, filed on October 22, 1996, is hereby terminated.


