JOURNAL ENTRY OF SATISFACTION

COMES NOW the Kansas State Board of Healing Arts (“Board”), by and through its Executive Director, Kathleen Selzler Lippert (“Executive Director”), a duly authorized representative of the Board in accordance with K.S.A 2010 Supp. 77-514 to conduct summary proceedings pursuant to K.S.A 2010 Supp. 77-537, and, pursuant to the authority in K.S.A. 65-5401, *et seq.*, and, in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501, *et seq.*, hereby enters the following findings of fact, conclusions of law, and Final Order in the above-captioned matter:

1. Pamela Schmidt Lacuesta, O.T. (“Licensee”), **Confidential** Kansas City, Missouri, 64137, is licensed to practice as a occupational therapist in the State of Kansas, Certificate No. 17-02472, and has been so licensed since February 11, 2008.

2. On September 10, 2013, the Executive Director issued a Summary Order regarding Licensee’s licensed to practice as an occupational therapist in the State of Kansas.

3. The Summary Order contained a notice that a written request for hearing could be filed within 15 days following service, but if no hearing was requested, the Summary Order would become effective as a Final Order of the Board upon expiration of the time for requesting a hearing.

4. No hearing has been requested by any party.

5. The Summary Order contained a provision assessing a CIVIL FINE against

Licensee in the amount of \$100.00 due on or before October 15, 2013.

6. The Summary Order ordered Licensee to submit proof of 40 hours of continuing education, due within 30 days of the effective date of the Summary Order.

7. The Summary Order provided that Licensee's license shall be suspended for failure to provide documented evidence of 40 continuing education hours within 30 days of the effective date of the Summary Order.

8. The Summary Order provided that Licensee's license shall be suspended for failure to pay the \$100.00 civil fine on or before October 15, 2013.

9. On October 7, 2013, Licensee remitted \$100.00 to the Board for satisfaction of the civil fine.

10. On September 19, 2013, Licensee submitted proof of the required hours of continuing education to the Board for satisfaction of the Summary Order.

IT IS, HEREBY ORDERED BY THE KANSAS STATE BOARD OF HEALING ARTS THAT:

11. The Summary Order became effective as a Final Order on October 1, 2013.


12. Licensee has satisfied the provision of the Summary Order requiring payment of the civil fine.

13. Licensee has satisfied the provision of the Summary Order requiring submission of the specified continuing education hours.

14. Licensee has satisfied all requirements of the Summary Order and has no further obligation for compliance.

15. The Board shall maintain jurisdiction over this matter to issue any Order(s) deemed necessary and appropriate.


