



FINAL ORDER TERMINATING CONSENT ORDER

NOW on this 8th day of February, 2013, comes before the Kansas State Board of Healing Arts, the request of Margaret Smith, M.D. (“Licensee”) for termination of the Consent Order filed in this matter on December 19, 2011. In accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501, *et seq.*, and upon due consideration of the agency record and applicable statutes, and being otherwise duly advised in the premises, the Board makes the following determinations:

1. Licensee is licensed to practice medicine and surgery in the State of Kansas, having been issued License No. 04-35544 on approximately February 24, 2012.
2. On or about December 18, 2011, Licensee entered into a Consent Order with the Board as a condition to being granted a license to practice medicine and surgery in the State of Kansas. due to the length of time Licensee had been absent from the active practice of medicine and surgery. The Consent Order was filed with the Board on December 19, 2011.
3. Under the terms of the Consent Order, Licensee agreed to a limitation on her license which required her to enter into and comply with a Clinical Practice Reentry Plan with the Center for Personalized Education for Physicians (“CPEP”).
4. The terms of the Consent Order allow Licensee to request termination of the provisions of the Consent Order upon successful completion.


5. On November 21, 2012, Licensee submitted a request to terminate the Consent Order's limitation and requirement that she participate in the CPEP Clinical Practice Reentry Program. Such request was filed with the Board on January 15, 2013.

6. The Board finds that Licensee has demonstrated compliance with the Consent Order's limitation and requirements. The Board further finds that Licensee has satisfactorily demonstrated clinical competency such that the limitation on her license should be terminated.

7. The Board concludes that the Consent Order should be terminated and Licensee should have no further obligation for compliance.

IT IS THEREFORE ORDERED, BY THE KANSAS STATE BOARD OF HEALING ARTS that the Consent Order filed December 19, 2011, in this matter is hereby **TERMINATED** and Licensee shall have no further obligation for compliance. Licensee's license is further restored to unrestricted status.


