**JOURNAL ENTRY EXTENDING DEADLINE TO
COMPLETE CONTINUING EDUCATION REQUIREMENT**

COMES NOW the Kansas State Board of Healing Arts ("Board"), by and through its Executive Director, Kathleen Seller Lippert, in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501 et seq., as amended, and upon due consideration of the file and the applicable statutes and otherwise being duly advised in the premises, makes the following determinations:

1. On or about July 11, 2011, Mr. Lamb submitted an application for licensure to practice as a physician assistant in the State of Kansas, which was deemed complete and filed with the Board on August 30, 2011

2. At the time application was made to this Board, Mr. Lamb held an active physician assistant license in Oklahoma, having been issued this license on April 1, 2010.

3. Mr. Lamb disclosed on his application for Kansas licensure that he had been previously disciplined by the Oklahoma Board for violating the Oklahoma Physician Assistant Practice Act, being found guilty of unprofessional conduct for prescribing controlled substances in a prohibited manner.

4. Petitioner filed a Response stating that, pursuant to K.S.A. 65-2805(a), as further defined by K.A.R. 100-28a-8(h), there were grounds to deny Mr. Lamb's application for a license to practice as a physician assistant in the State of Kansas.

5 Upon consideration by the full Board at the October 21, 2011, conference hearing, Mr. Lamb was granted licensure with a non-disciplinary continuing education requirement.

6 On February 20, 2012, an Agreed Final Order Granting License, entered into between the parties, was filed with the Board.

7 The Agreed Final Order required Mr. Lamb to attend and successfully complete, at his own expense, a continuing education course pre-approved by the Board's designee on the subject of prescribing controlled substances.

8 The Agreed Final Order required Mr. Lamb to provide the Board with proof of successful completion of this continuing education course on or before August 30, 2012.

9 On or about April 25, 2012, Mr. Lamb's attorney contacted the Board seeking an extension of the continuing medical education requirement deadline to October 31, 2012.

10 Mr. Lamb's attorney informed the Board that the pre-approved course takes place on September 21, 2012, therefore, an extension to October 31, 2012 in order to provide the Board with proof of successful completion of the continuing education course is appropriate.


11 For good cause shown, the requirement to provide the Board with proof of successful completion of the continuing education course should be granted.

IT IS THEREFORE ORDERED, BY THE KANSAS STATE BOARD OF HEALING ARTS that the non-disciplinary continuing education requirement deadline set forth in the Agreed Final Order Granting License is hereby extended to October 31, 2012.

IT IS FURTHER ORDERED that all other requirements of the Agreed Final Order Granting License in this matter are incorporated herein, and are to remain the Final Order of the Board.

IT IS FURTHER ORDERED that the Board shall maintain jurisdiction over this matter to issue any further Order(s) deemed necessary and appropriate.


