FINAL ORDER TERMINATING MONITORING REQUIREMENTS

NOW on this 12th day of April 2013, comes before the Kansas State Board of Healing Arts (“Board”) the request of Matthew Lane, D.C. (“Licensee”) for termination of the monitoring requirements set forth in Consent Order. Licensee appears in person and pro se. Stacy R. Bond, Associate Litigation Counsel, appears on behalf of the Respondent Board.

Pursuant to the authority granted to the Board by K.S.A. 65-2801 *et seq.* and in accordance with the provisions of the Kansas Administrative Procedure Act K.S.A. 77-501 *et seq.*, the Board hereby enters this Final Order in the above-captioned matter. After reviewing the file, hearing the statements and arguments of the parties, and being otherwise duly advised in the premises, the Board makes the following findings, conclusions and orders:

1. Matthew Lane, D.C. (“Licensee”), is licensed to engage in the practice of chiropractic in the State of Kansas, License No. 01-05491, and has been so licensed since approximately June 27, 2012.

2. On or about April 13, 2012, Licensee entered into a Consent Order with the Board

4. The monitoring requirements were not self-terminating. The terms of the Consent Order allowed Licensee to request the Board for modification or termination of the requirements after a one (1) year monitoring period.

5. Reports concerning Licensee's compliance Confidential were submitted to the Board. The documentation submitted indicated that Licensee had fulfilled the terms of the monitoring set forth in the Consent Order.

6. On or about March 8, 2013, Licensee submitted a request to the Board for termination of the monitoring requirements imposed by the Consent Order.


7. On March 15, 2013, the Respondent Board filed a Response to Licensee's request.

8. Upon review of the evidence presented, the Board determined that Licensee has satisfactorily met all monitoring requirements of the Consent Order sufficient to warrant termination, and has no further obligation for compliance.

IT IS THEREFORE ORDERED, BY THE KANSAS STATE BOARD OF HEALING ARTS, that Licensee has satisfied all terms and conditions of the Consent Order and that Licensee's request to terminate the monitoring requirements imposed by the Consent Order is hereby granted.

IT IS FURTHER ORDERED that the Board shall maintain jurisdiction over this matter to issue any future order(s) deemed necessary and appropriate.

Additionally, a party to an agency proceeding may seek judicial review of a Final Order by filing a petition in the District Court, as authorized by K.S.A. 77-601, *et seq.* Reconsideration of a Final Order is not a prerequisite to judicial review. A petition for judicial review is not timely unless filed within **30 days** following service of the Final Order.
