WHEREUPON the Summary Order publicly censored Licensee and fined him \$2500.


WHEREUPON Licensee has already undertaken corrective measures.

A party to an agency proceeding may seek judicial review of a final order by filing a petition in the District Court as authorized by K.S.A. 77-601, et seq. Reconsideration of a final order is not a prerequisite to judicial review. A petition for judicial review is not timely filed unless filed within 30 days following service of the

final order. A copy of any petition for judicial review must be served upon Jack Confer, the Board's Acting Executive Director, at 235 SW Topeka Blvd., Topeka, KS 66603.




Wherefore, the Board finds as follows:
