FINAL ORDER FOLLOWING CONFERENCE HEARING

NOW, on this 27th day of April, 1996, this matter comes on for consideration before the Kansas State Board of Healing Arts ("Board") sitting as a whole as presiding officer in a conference proceeding pursuant to the provisions of K.S.A. 77-533 through 77-535, the application for status change from exempt to active status submitted by James A. Lasseter, M.D. ("Licensee") on January 29, 1996.

After reviewing the application and being otherwise duly advised in the premises, the Board finds as follows:

1. Licensee was originally licensed to practice medicine and surgery in the State of Kansas on June 15, 1990.
2. On March 1, 1993, the Board and Licensee entered into a Stipulation and Agreement and Enforcement Order which was filed in the Board office on March 2, 1993, in which

Licensee acknowledged that on January 28, 1993, Licensee had voluntarily suspended his practice of medicine and surgery and had placed his license on an inactive status.

3. Licensee failed to renew his license for the period of July 1, 1993 through June 30, 1994, and, therefore, his license to practice medicine and surgery in the State of Kansas was cancelled on August 23, 1993.

4. On April 4, 1995, Licensee filed an Application for Reinstatement of his license together with an application that such license, if reinstated, be placed on exempt status.

5. On April 29, 1995, Licensee's Application for Reinstatement was granted and Licensee's license to practice medicine and surgery in the State of Kansas was reinstated on an exempt status. The Stipulation and Agreement and Enforcement Order filed March 2, 1993 was terminated. Licensee was ordered that should he desire to convert his license to active status, Licensee shall be required to comply with all requirements of the Board and the Board may consider all previous investigative information and formal proceedings in determining Licensee's present competency in determining if the status of his license should be converted to active.

6. On January 29, 1996, Licensee submitted an application for exempt to active status.

IT IS THEREFORE BY THE BOARD ORDERED as follows:

b) The application to convert Licensee's license from exempt to active status is granted.

IT IS FURTHER ORDERED that this is a Final Order and is effective upon service upon the parties. Any party may, within fifteen (15) days after service, file a Petition for Reconsideration, stating the specific grounds upon which relief is requested. The filing of a Petition for Reconsideration is not a prerequisite for seeking administrative or judicial review.

IT IS SO ORDERED.


