PROPOSED DEFAULT ORDER

On June 14, 2019, the Kansas Board of Healing Arts (Board) held a Conference Hearing on the Petition filed against Jeffrey T. Lefkovitz, D.C.'s ("Licensee") license to practice as a chiropractor in Kansas. Licensee did not appear. Susan R. Gering, Litigation Counsel, appeared to present the Petition on behalf of the disciplinary panel of the Board. The members of the disciplinary panel were recused from the Board's consideration of this matter.

Under the authority granted to the Board by K.S.A. 65-2801 *et seq.* and in accordance with the provisions of the Kansas Administrative Procedure Act K.S.A. 77-501 *et seq.*, the Board enters this Proposed Default Order in the above-captioned matter.

Upon review of the Petition, Licensee's Answer, exhibits submitted, and being fully advised in the premise, the Board holds Licensee in DEFAULT for his failure to appear at the June 14, 2019, Conference Hearing on this matter, and makes the following determinations:

FACTS

 A Conference Hearing on the Petition against Licensee's license was noticed for June 14, 2019.

2. Pursuant to K.S.A. 77-531, Licensee was served with a Notice of Conference Hearing to Applicant's mailing address via United States Mail, first-class postage prepaid, on or about May

13, 2019, and May 24, 2019. The Notice of Conference Hearing provided Licensee notice that any party who fails to attend or participate in the Conference Hearing or other stage of a proceeding may be held in default.

3. Licensee failed to appear at the Conference Hearing held on June 14, 2019.

4. The Board finds the facts set forth in the Petition are incorporated here by reference.

CONCLUSIONS OF LAW

5. Pursuant to K.S.A. 77-520, Licensee is in default for his failure to appear at the Conference Hearing held on June 14, 2019.

6. The Board concludes Licensee has violated the Kansas Healing Arts Act, specifically,K.S.A. 65-2836(k), in that Licensee has violated a lawful order or directive entered by the Board,by failing to pay board costs of \$10,271.09 assessed to him.

IT IS THEREFORE ORDERED, BY THE KANSAS STATE BOARD OF HEALING ARTS that Licensee is hereby held in DEFAULT pursuant to K.S.A. 77-520.

IT IS FURTHER ORDERED that Licensee pay board costs, in the amount of \$10,271.09 within 60 days of this Proposed Default Order, becoming a Final Order.
