**SUMMARY ORDER EXTENDING TEMPORARY LICENSE**

**NOW**, on this 6<sup>TH</sup> day of December, 2003, comes on for Summary Proceedings before the Kansas State Board of Healing Arts (hereafter "Board") the request of Bobbi Tenille Lesperance-Holmes, P.A. (hereafter "Applicant") to extend her temporary license. Charlene K. Abbott, Licensing Administrator, presents information to the Board. There are no other appearances.

After hearing statements from the Licensing Administrator and being duly advised in the premises, the Board finds and orders as follows:

1. Applicant was issued temporary license number 0326197 under the provisions of K.S.A. 65-28a07 to provide patient services as a physician assistant for the period of December 18, 2002 until December 18, 2003.

2. On December 5, 2003, Applicant filed a request for an extension of the temporary license and provided information with that request indicating she was confidential from January 1, 2003 through July 1, 2003 and was confidential that it would not be beneficial for her to attempt the examination required for permanent license during that period.

3. K.S.A. 65-28a07(b) authorizes the board to extend a temporary license, upon a majority vote of the members of the Board, for a period not to exceed one year.

4. Temporary license number 0326197 issued to Applicant should be extended until April 17, 2004.

**IT IS THEREFORE ORDERED** that temporary license number 0326197 issued to Bobbi Tenille Leeperance-Holmes, P.A. be extended from December 18, 2003 through April 17, 2004.

**PLEASE TAKE NOTICE** that this is a summary order. A party to whom a summary order is issued may file a written request for a hearing within 15 days following service of the summary order. If a hearing is not requested, the summary order shall become effective as a final order of the board upon expiration of the time for requesting a hearing.
