Wherefore, the Board finds as follows:

1. On or about December 6, 1997, the Board issued a Final Order in regards to Licensee's ability to practice medicine and surgery in the state of Kansas. The Final Order contained a provision for Licensee to pay the costs of the matter of \$1662.00, payable upon the effective date of the order. The Final Order became effective on December 10, 1997.

2. Licensee may no efforts to pay the costs of this matter until June 28, 2007. At that time payment plan was arranged where Licensee made sixteen (16) payments of \$100.00 and one final payment of \$62.00.


3. Licensee made the final \$62.00 payment on December 1, 2008.


