**FINAL ORDER FOLLOWING CONFERENCE HEARING**

NOW, on this 12<sup>th</sup> day of June, 1999, this matter comes on for consideration before the Kansas Board of Healing Arts (hereafter "Board"), sitting as a whole as presiding officer in a conference proceeding pursuant to the provisions of K.S.A. 77-533, the request of Bruce Irwin Lieberman, M.D. (hereafter "Licensee") for reinstatement of license.

Shelly Wakeman, Disciplinary Counsel, presented information before the Board. Licensee appeared in person *pro se*.

After hearing statements of the parties and being otherwise duly advised in the premises, the Board finds as follows:

1) Licensee failed to renew license number 4-18413 which was originally issued on December 14, 1979, and said license was subsequently cancelled August 1, 1998 for failure to renew pursuant to K.S.A. 65-2809 and amendments thereto.

2) Licensee continued to practice medicine and surgery in Kansas for at least seven months from and after August 1, 1998 until March 1, 1999 while his license was canceled. Practicing without a valid Kansas medical license is a violation of K.S.A. 65-2801 *et seq.*

3) On May 7, 1999, Licensee filed an Application for Reinstatement to practice medicine and surgery in the state of Kansas accompanied by the mandatory proof of insurance and proper fee. Licensee understands and further requests that since he practiced during the time his license was

cancelled his original request now be amended to allow him retroactive reinstatement from August 1, 1998 to June 12, 1999.

**IT IS THEREFORE BY THE BOARD ORDERED** as follows:

a) That the findings here and above made be and the same are made the order of the Board.  
b) That license number 4-18413 issued to Licensee which was canceled on August 1, 1998 be reinstated effective June 12, 1999.


c) That a fine in the amount of \$500 be assessed against Licensee and upon payment of said fine within 30 days of the date of this Order, Licensee's license be retroactively reinstated from August 1, 1998 to June 12, 1999.

d) This is a Final Order and is effective upon service upon the parties. Any party may, within fifteen (15) days after service, file a Petition for Reconsideration. The filing of a Petition for Reconsideration is not a prerequisite for seeking administrative or judicial review.

**IT IS SO ORDERED.**


