JOURNAL ENTRY AND FINAL ORDER

NOW on this the 23rd day of September, 2003, comes on for pre-hearing conference the above-captioned matter before Presiding Officer John P. Gravino, D.O. Applicant A. Y. Valdemar Lindquist, M.D. appears by telephone and Kelli Benintendi, Associate Counsel appears in person on behalf of the Board. Following the pre-hearing conference, the parties announce to the Presiding Officer that they have reached an agreement in this matter. After reviewing the agency record, hearing the statements of the parties and otherwise being fully advised in the premises, the Presiding Officer finds as follows:

1. On or about January 6, 2003, Applicant submitted an Application for Licensure to practice medicine and surgery in Kansas.
2. Applicant was unable to provide documentation of his medical education grade transcripts and postgraduate training in England from 1965 to 1969.
3. Applicant completed a fellowship at the University of Colorado Health Sciences Center from September 1, 1969 to June 30, 1971.
4. Applicant is licensed by the Colorado Board of Medical Examiners to practice medicine without restriction in Colorado, and has held a license in that state since 1974.

5. Applicant did not actively practice medicine and surgery from September of 1992 to September of 2001.

6. A conference hearing was held in this matter on June 7, 2003, at which the Board determined that Applicant satisfactorily demonstrated that he successfully completed his medical education and postgraduate training and that the requirements for providing such transcripts and proof of Applicant's postgraduate training should be waived.

7. At the conference hearing, the Board determined that more information was necessary regarding Applicant's clinical competency and converted this matter to a formal hearing and appointed a Presiding Officer with authority to issue a Final Order

8. Applicant previously submitted to an evaluation of his clinical competency at the Center for Personalized Education for Physicians ("CPEP") on September 19-20, 2002. Applicant provided the Presiding Officer with a copy of the CPEP Assessment Report of Applicant's clinical competency.

9. Since September of 2002, Applicant has practiced medicine in Colorado, serving as a medical house officer for a plasmapheresis clinic and performing outpatient pulmonary consultations as part of a group practice.

10. Applicant's intended scope of practice activities in Kansas is as follows:

- a. Pulmonary consulting and follow-up care for outpatients approximately two days per month at Goodland Regional Medical Center.

- b. Reading, interpreting and dictating reports of pulmonary function tests.
- c. Occasional inpatient pulmonary consultations. After the initial consult, the patient will be followed by the staff physicians at Goodland Regional Medical Center.
- d. Applicant will not be performing any procedures.

11. Based on Applicant's experience, current practice activities and the Assessment Report from CPEP, the Presiding Officer finds that Applicant is clinically competent to perform the practice activities described above.

12. The Presiding Officer finds that upon meeting all other requirements for licensure not specifically waived by this Order, Applicant should be granted an active license to practice medicine and surgery in Kansas. Such license shall be granted without restriction. However, Applicant agrees to notify the Board at least thirty (30) days prior to any additions or changes in his practice activities in Kansas as set forth in paragraph 10 above.

IT IS THEREFORE ORDERED that the requirements for providing medical education grade transcripts and proof of Applicant's postgraduate training are waived.


IT IS FURTHER ORDERED that upon meeting all requirements for licensure not specifically waived by this Order, Applicant shall be granted an active license to practice medicine and surgery in Kansas.

IT IS FURTHER ORDERED that Applicant shall notify the Board at least thirty (30) days prior to any additions or changes in his practice activities in Kansas as set forth in paragraph 10 above.






