
NOW on this 12<sup>th</sup> day of October, 2012, this matter comes before Kathleen Selzler Lippert, Executive Director, Kansas Board of Healing Arts (“Board”), concerning Nicholas Lockrow, D.C. (“Applicant/Licensee”) Consent Order and Joint Motion for Journal Entry Rescinding Applicant/Licensee’s Consent Order, Cancelling his Temporary License and Staying the Application Proceeding. Wherefore, the Board finds as follows:

1. On or about September 20, 2012, a Consent Order was filed by the Board issuing Applicant/Licensee a Temporary License to practice chiropractic in the State of Kansas, and placing requirements upon his licensure to practice chiropractic in the State of Kansas.
2. The parties are no longer in agreement to the terms of the Consent Order.
3. The parties agree that the Consent Order should be rescinded, thereby cancelling Applicant/Licensee’s Temporary License to practice chiropractic in the State of Kansas.
4. The parties also agree that it would be appropriate for the Applicant/Licensee’s application proceeding be stayed until such time Applicant/Licensee believes he is ready to bring this matter back in front of the Board to determine whether a permanent license should be granted.

**IT IS THEREFORE ORDERED** that Applicant/Licensee's Consent Order dated September 20, 2012 is hereby RESCINDED thereby CANCELING immediately his Temporary License to practice chiropractic in the State of Kansas.

**IT IS FURTHER ORDERED** that Applicant/Licensee's application proceeding is hereby STAYED until such time Applicant/Licensee he is ready to bring this matter back in front of the Board to determine whether a permanent license should be granted.
