FINAL ORDER

NOW ON THIS 10th day of December 2005, this matter comes on for hearing. Respondent Daniel Philip Logan, M.D. appears in person and without counsel. Kelli J. Stevens, Litigation Counsel, appears for the Board.

Having the agency record before it, the Board finds, concludes and orders as follows:

1. The Board initiated a proceeding April 4, 2004 alleging that Dr. Logan had violated the healing arts act. That proceeding was concluded August 16, 2004 with the approval of a Consent Order. The Consent Order imposed limitations on Dr. Logan's license. One limitation prohibits him from ordering, prescribing, distributing or administering controlled substances.
2. Dr. Logan requests that the Board terminate the limitation regarding controlled substances. The purpose for the request is to allow him to participate in a fellowship in addiction medicine at the University of Florida at Gainesville.
3. The Board finds reason to believe that Dr. Logan is sufficiently rehabilitated to warrant the public trust while participating in the fellowship program.

4. The Board further finds that all other limitations appearing in the August 16, 2004 Consent Order should remain in affect. For purposes of that order, the Board concludes that Dr. Logan is not limited from providing urgent care, including treating lacerations and from performing minor medical and surgical procedures that do not involve the administration of controlled substances, in other than a medical care facility's emergency department.

5. The Board further finds and concludes that in the event that Dr. Logan does not enter, or enters but does not complete, the fellowship program, that the Board should, on its own motion, reconsider this order.

IT IS, THEREFORE, ORDERED that the limitation on the license of Daniel P. Logan, M.D., prohibiting him from ordering, prescribing, distributing, or administering controlled substances is hereby terminated.

IT IS FURTHER ORDERED that Daniel P. Logan, M.D. shall notify the Board in writing if he does not enter the fellowship program in addiction medicine at the University of Florida at Gainesville, and shall notify the Board in writing if he does not complete the program for any reason. Such notice shall be given within five calendar days after he knows or has reason to know that he will not enter or complete the program.

PLEASE TAKE FURTHER NOTICE that this is a final order. A final order is effective upon service. A party to an agency proceeding may seek judicial review of a final order by filing a petition in the District Court as authorized by K.S.A. 77-601, et seq. Reconsideration of a final order is not a prerequisite to judicial review. A petition for judicial review is not timely unless filed within 30 days following service of the final

order. A copy of any petition for judicial review must be served upon the Board's Executive Director at 235 SW. Topeka Blvd., Topeka, KS 66603.
