FINAL ORDER FOLLOWING CONFERENCE HEARING

NOW, on this 9th day of December, 1994, comes on for conference proceedings the request of Alice Amukasa Lubanga, (hereafter "Applicant") to grant a second temporary registration pursuant to K.S.A. 65-5408(d).

Applicant does not appear. Charlene K. Abbott, Licensing Administrator, appeared to present information to the Board. There are no other appearances.

After reviewing the files and being duly advised in the premises, the Kansas State Board of Healing Arts (hereafter "Board") makes the following findings of facts, conclusions of law and order:

1. A request for a second temporary registration was filed by Applicant on November 21, 1994.

2. Notice of Conference Hearing setting this matter for hearing at 10:30 a.m. on December 9, 1994 was filed herein on November 23, 1994 and served on Applicant on that same date.

3. Applicant has applied for permanent registration as a occupational therapist, but has not passed an exam approved by the Board as required by K.S.A. 65-5406.

4. Applicant was granted a temporary registration on December 21, 1993 and which expires on December 21, 1994.

5. Pursuant to K.S.A. 65-5408(d) no more than one such temporary registration shall be permitted to any one person without the majority approval of the members of the Board.

6. Applicant took and failed the examination administered in July, 1994 and is registered to sit for the January, 1995 AOTCB examination.

IT IS THEREFORE ORDERED that a second temporary registration for the purposes of holding oneself out as a occupational therapist be issued to Applicant effective from December 21, 1994 and to expire on December 21, 1995 upon payment of the required fee for such second temporary registration.

IT IS FURTHER ORDERED that this is a Final Order and is effective upon service upon the parties. Any party may, within 15 days after service, file a Petition for Reconsideration. The filing of a Petition for Reconsideration is not a prerequisite for seeking administrative or judicial review.

IT IS SO ORDERED.
