**FINAL ORDER FOLLOWING CONFERENCE HEARING**

**NOW**, on this 16th day of August, 1997, this matter comes before the Kansas State Board of Healing Arts (hereinafter referred to as "Board") sitting as a whole, the application of Peter Joseph Macander, M.D., (hereinafter "Applicant") for a permanent license to practice medicine and surgery in the State of Kansas.

Applicant appeared in person pro se. Charlene Abbott, Licensing Administrator of the Board, presented information to the Board.

After reviewing the file, hearing statements and being otherwise duly advised in the premises, the Board finds as follows:

1. On April 21, 1997, Applicant filed an Application for Endorsement to obtain a permanent license to practice medicine and surgery in the State of Kansas.
2. As part of that application, Applicant was asked to provide information pertaining to his educational background, Section X of the application.
3. Applicant stated that Polish Medical Academies do not produce or send out transcripts. He provided the Board with information that reflected he had graduated from

medical school in Poland.

4. Applicant also provided evidence of completion of several residency programs in the United States.

5. The Board reviewed the application and found that information provided is substantially equivalent to Section X and accepted it in lieu of completion of that section.

**IT IS THEREFORE ORDERED** as follows:


(a) Required completion of Section X on the Application for Endorsement is waived. Applicant's application for licensure will be placed on the list for approval at the October Board meeting.

(b) Either party is entitled to an administrative review of this Order if written request is received in the Board office within fifteen (15) day of service of this Order upon the parties.
