

2. The Summary Order was mailed on November 7, 2007, and contained a notice that it would become effective within 15 following service if no request for hearing was received prior to the effective date of the Summary Order.

2. No hearing has been requested by any party and, therefore, the Summary Order became effective on November 29, 2007, and the fine in the amount of \$1,187.50 is due and payable on or before December 29, 2007.



OF REQUIREMENTS OF SUMMARY ORDER**

NOW on this 29TH day of December, 2008, this matter comes before John (Jack) Confer, Acting Executive Director, Kansas Board of Healing Arts ("Board"), concerning Licensee's satisfaction of all requirements contained in the Summary Order which was filed on September 10, 2008. Wherefore, the Board finds as follows:


1. On or about November 7, 2007, the Board issued a Summary Order address concerns about Licensee practicing as an Occupational Therapist in the state of Kansas after her license was canceled. The Summary Order contained a provision for Licensee to pay a fine in the amount of \$1187.50, payable within 30 days of the effective date of the Summary Order. The Summary Order became final on November 29, 2007.
2. As per the Amended Journal Entry filed on December 4, 2007, Licensee was to make monthly payments to satisfy the civil fine in the amount of \$1,187.50. Licensee was to make one payment of \$50 prior to December 31, 2007 and to make monthly payments of \$100 prior to the end of each month thereafter until paid in full.
3. On December 8, 2008, Licensee made her final payment.
4. Licensee has satisfied all requirements of the Summary Order and has no further obligation for compliance.

IT IS THEREFORE ORDERED that Licensee is hereby discharged from the

requirements of the Summary Order filed on November 7, 2007.


