ORDER OF DISMISSAL

NOW, on this 13th day of August, 1994, comes on for consideration before the Kansas State Board of Healing Arts ("Board") sitting as a whole in conference proceeding the Application for Registration as an Occupational Therapist filed by Nesian Jean Makesh, O.T. ("Applicant"). The Board appears by and through Charlene K. Abbott Licensing Administrator. Applicant does not appear.

After reviewing the file and being duly advised in the premises, the Board finds and orders as follows:

1. On June 17, 1994, the Board received notification that Applicant would not be arriving in the United States and that the application should be considered as withdrawn.

2. That the temporary permit issued to Applicant on December 20, 1993 to expire on December 20, 1994 should be canceled and no longer has any force or effect.

IT IS THEREFORE BY THE BOARD ordered that the Board accepts request for withdrawal of the application without prejudice to any issues.


IT IS FURTHER ORDERED that the conference proceedings on the Applicant's Application for Registration as an Occupational Therapist be dismissed as moot.
