**FINAL ORDER GRANTING LICENSURE BY ENDORSEMENT**

NOW on this 9th day of August 2013, comes before the Kansas State Board of Healing Arts (“Board”) the application of Shivarajan Manickavasagam Amudhavalli, M.D. (“Applicant”) for a license to practice medicine and surgery in the State of Kansas. Applicant appears in person and *pro se*. Reese Hays, Litigation Counsel, appears on behalf of the Board.

Pursuant to the authority granted to the Board by the Kansas Healing Arts Act, K.S.A. 65-2801, *et seq.* and in accordance with the provisions of the Kansas Administrative Procedure Act K.S.A. 77-501, *et seq.*, the Board hereby enters this Final Order in the above-captioned matter. After reviewing the agency record, hearing the statements and arguments of the parties, and being otherwise duly advised in the premises, the Board makes the following findings, conclusions and order:

1. On or about December 27, 2012, Applicant submitted an application to the Board for a license to practice medicine and surgery in the State of Kansas. Such application was complete and filed with the Board on July 9, 2013.
2. Applicant requests that he be granted licensure by endorsement pursuant to K.S.A. 65-2833 based on his medical licenses in the State of Missouri and Maryland.

3. Applicant graduated from medical school in 1999 from Madras Medical College in India.


4. Applicant currently holds an active medical licenses in Missouri and Maryland which have not been subject to discipline.

5. Applicant has engaged in the active practice of medicine in Missouri since October of 2012.

6. The Board finds that Applicant has demonstrated satisfactory fulfillment of K.S.A. 65-2833 to be granted a license by endorsement to practice medicine and surgery in the State of Kansas.

**IT IS THEREFORE ORDERED, BY THE KANSAS STATE BOARD OF HEALING ARTS** that Applicant is hereby GRANTED a license by endorsement to practice medicine and surgery in the State of Kansas.


