FINAL ORDER FOLLOWING CONFERENCE HEARING

NOW, on this 16th day of October, 2004, comes on for Conference Hearing before the Kansas State Board of Healing Arts ("Board") the Application for Licensure to practice medicine and surgery in the state of Kansas filed by Manuel I. Marban, M.D. ("Applicant").

Charlene K. Abbott, Licensing Administrator, presented information before the Board. Applicant appeared in person *pro se*.

After reviewing the file, hearing the statements of Ms. Abbott and Applicant and being otherwise duly advised in the premises, the Board finds and orders as follows:

- 1. On July 12, 2004, Applicant filed an Application for Licensure to receive a license to practice medicine and surgery in the state of Kansas.
- 2. As part of the Application, Applicant provided evidence that he completed the degree program in medicine and surgery at the University of Santo Tomas, Faculty of Medicine and Surgery, Manila, Philippines and was issued the degree of doctor in medicine and surgery on April 16, 1964.
- 3. The University of Santo Tomas, Faculty of Medicine and Surgery, Manila, Philippines, is not an accredited medical school.

- 4. K.S.A. 65-2873(c)(2) provides that an applicant from a school that is not accredited may be granted a license if the applicant has completed three years of postgraduate training as approved by the Board.
- 5. The Board has adopted K.A.R. 100-6-2(b) that requires applicants who graduated from an unaccredited school of medicine to provide proof of completion of at least two years of postgraduate training approved by the council of education of the American Medical Association or its equivalent.
- 6. Applicant has provided a notarized certificate of completion of a one-year fellowship in surgical pathology at St. John's Mercy Medical Center, St. Louis, Missouri.
- 7. Applicant has indicated on his Application that he completed a one-year internship and a one-year residency in anatomic pathology at Evangelical Deaconess Hospital, Milwaukee, Wisconsin, from July 1, 1966 through June 30, 1968, but cannot locate certificates for completion and that the hospital is no longer in existence. In lieu of notarized certificates of completion, Applicant provided a photograph of the House Staff at the hospital and affidavits from two physicians who served with Applicant at Evangelical Deaconess Hospital. In addition, the Physician Profile for Applicant received by the Board from the American Medical Association indicates that Applicant's successful completion of the internship and residency at Evangelical Deaconess Hospital has been verified by that organization.
- 8. The information provided to the Board provides satisfactory proof that Applicant has completed three years of postgraduate training with at least two of those years being in programs approved by the council of education of the American Medical Association in compliance with K.S.A. 65-2873(c)(2) and K.A.R. 100-6-2(b).

IT IS THEREFORE ORDERED that the above findings are made the order of the Board and that Applicant has met the postgraduate training requirements of K.S.A. 65-2873(c)(2) and K.A.R. 100-6-2(b).
