COMES NOW, this 19th day of October, 1996, the Kansas State Board of Healing Arts ("Board") sitting in conference hearing to hear the Request for Modification of Stipulation and Agreement and Enforcement Order of Jeffrey C. Mathis, O.T. ("Registrant") to modify the Stipulation and Agreement and Enforcement Order ("Stipulation") filed March 1, 1996. The Board appears by and through its Disciplinary Counsel, Kevin K. LaChance ("Petitioner"). Registrant appears by and through his counsel, Mr. Steve A. Schwarm, of Goodell, Stratton, Edmonds & Palmer, Topeka, Kansas.

After consideration of the request, and presentations of counsel, the Board orders the following:

1. The monitoring reports received indicate it is appropriate to reduce the reporting requirements to the level specified in Paragraph 6(c)(iv)(1) of the Stipulation.
2. By agreement of counsel, the question pertaining to pediatric occupational therapy practice is tabled until the December 1996 Board meeting, tentatively scheduled for December 6-7, 1996.
3. The Disciplinary Panel of the Board is hereby delegated authority to approve a pediatric occupational therapist to work with Registrant.


