**ORDER MODIFYING AGREEMENT**  
**AND ENFORCEMENT ORDER**

NOW ON THIS Fifteenth day of February, 1997, comes on for conference hearing the request of Jeffrey C. Mathis, O.T. to modify the agreement and enforcement order entered February 27, 1996. Mr. Mathis appears in person and through counsel, Steve A. Schwarm. The Board appears through Kevin K. LaChance, Disciplinary Counsel.


After hearing the arguments of counsel and having the record before it, the Board finds that Mr. Mathis' request should be granted, and that the prior agreement and order should be modified as follows:

1. The limitation providing that Mr. Mathis not practice pediatric occupational therapy is lifted.
2. The second six-month billing audit as provided by the agreement and enforcement order is scheduled to commence on or about February 27, 1997. Memorial Hospital personnel are approved to conduct the audit.

3. Monitoring reports as required by the agreement and enforcement order are to be provided every two months for the duration of the agreement and enforcement order.

IT IS SO ORDERED, this 4<sup>th</sup> day of March, 1997.


