**JOURNAL ENTRY FINDING SATISFACTION OF CONSENT ORDER  
REQUIREMENTS**

**(Pursuant to K.S.A. 77-501 et seq.)**

NOW on this 15 day of April 2011, comes before the Kansas State Board of Healing Arts (“Board”) the Motion of Glenda Maurer, M.D. (“Licensee”) for Journal Entry Finding Satisfaction of Consent Order Requirements. Licensee appears by and through counsel, Frankie J. Forbes of Forbes Law Group, LLC. Janith A. Lewis, Associate Litigation Counsel, appears on behalf of the Respondent Board.

Pursuant to the authority granted to the Board by K.S.A. 65-2801 *et seq.* and in accordance with the provisions of the Kansas Administrative Procedure Act K.S.A. 77-501 *et seq.*, the Board hereby enters this Journal Entry of Satisfaction in the above-captioned matter. After reviewing the file, hearing the statements and arguments of Ms. Lewis and Mr. Forbes and being otherwise duly advised in the premises, the Board makes the following findings of fact, conclusions and order:

**I. Findings of Fact**

The Board has been shown the following facts:

1. Glenda Maurer, M.D. (“Licensee”), is licensed to engage in the practice of medicine and surgery in the State of Kansas, License No. 04-26800, and has been so licensed since approximately April 5, 1997.

2. Licensee's last known mailing address provided to the Board is: 711 N. Norton Avenue, Norton, KS 67654.

3. On or about April 30, 2009, Licensee entered into a Consent Order with the Board. The Consent Order provided that Licensee completes an educational plan through the Center for Personalized Education for Physicians (CPEP), or to complete an alternative education plan that was approved by the presiding officer.

On or about June 3, 2009, Licensee presented an alternative educational plan offered through the PACE Program at the University of California, San Diego.

4. On or about November 5, 2009, the Board entered a Final Order accepting Licensee's alternative educational plan provided through the PACE Program at the University of California, San Diego. The PACE educational plan provided that Licensee would follow the educational plan for a minimum of twelve (12) months and that PACE would submit monthly progress reports to the Board's Compliance Coordinator.

5. The terms of the Consent Order dated April 30, 2009 are not self-terminating.

6. On or about February 3, 2011, a Motion for Journal Entry Finding Satisfaction of Consent Order Requirements was filed with the Board, in which Licensee requested a Journal Entry finding that she had satisfied the requirements of the April 30, 2009 Consent Order.

7. On April 15, 2011, Licensee presented evidence of her successful completion of her approved Pace education plan.

## **II. Applicable Law**

- a. K.S.A. 77-501 et seq. – Kansas Administrative Procedure Act
- b. K.S.A. 65-2801 et seq. – Kansas Healing Arts Act

### **III. Policy Statement**

The public policy of regulating the practice of healing arts in the State of Kansas is set forth in K.S.A. 65-2801:

Recognizing that the practice of the healing arts is a privilege granted by legislative authority and is not a natural right of individuals, it is deemed necessary as a matter of policy in the interests of public health, safety and welfare, to provide laws and provisions covering the granting of that privilege and its subsequent use, control and regulation to the end that the public shall be properly protected against unprofessional, improper, unauthorized and unqualified practice of the healing arts and from unprofessional conduct by persons licensed to practice under this act.

### **IV. Conclusions**

Based upon the Findings of Fact enumerated in Paragraph Nos. 1 through 7, Applicable Law, and the Policy Statement set forth above, the Board hereby concludes as follows:


8. Sufficient evidence has been presented to show Licensee has complied with the Consent Order that was dated April 30, 2009.

**IT IS THEREFORE ORDERED, BY THE KANSAS STATE BOARD OF HEALING ARTS:**

9. Licensee has satisfactorily met all requirements of the April 30, 2009, Consent Order and has no further obligation for compliance.

10. Licensee is hereby discharged from all requirements of the Consent Order filed on April 30, 2009.


