McCown, M.D. ("Licensee") that the Stipulation and Agreement and Enforcement Order filed on February 14, 2000, be terminated. Shelly Wakeman, Disciplinary Counsel, appeared for the Board. Licensee appeared in person, *pro se*.

After examining the files, hearing statements of the parties and being otherwise duly advised in the premises, the Board finds as follows:

1. A Stipulation and Agreement and Enforcement Order was entered into between Licensee and the Board and filed on February 14, 2000.
2. The Board is satisfied that Licensee has met the terms of the Stipulation and the conditions placed upon his license and as such, termination of the limitations is appropriate.
3. The Stipulation and Agreement and Enforcement Order filed on February 14, 2000, should be terminated and the limitations contained therein be removed from Licensee's license to practice medicine and surgery.

NOW, THEREFORE, it is ordered by the Board that the findings hereinabove made be
