SUMMARY ORDER

NOW ON THIS 1414 day of 1019 2019, this matter comes before Tucker Poling, Interim Executive Director, Kansas State Board of Healing Arts ("Board"), in summary proceedings pursuant to K.S.A. 77-537.

Pursuant to K.S.A 77-537 and K.S.A. 77-542, this Summary Order shall become effective as a Final Order, without further notice, if no written request for a hearing is made within 15 days of service. Upon review of the agency record and being duly advised in the premises, the following findings of fact, conclusions of law, and order are made for and on behalf of the Board:

## **Findings of Fact**

- Michael McDonald ("Licensee") was issued License No. 15-01641 on or about
   January 1, 2014 and is and has been entitled to practice as a physician assistant in Kansas, having
   last renewed such license on January 31, 2019.
  - 2. Licensee's last known mailing address to the Board is: CONFIDENTIAL
- Licensee's license to practice as a physician assistant in Kansas is currently Active
   and was Active during all times relevant to the facts set forth in this Summary Order.

4. On Licensee's most recent online license renewal, in answer to the question "Have

you paid the annual surcharge to the KHCSF?" Licensee selected "Y".

5. Pursuant to its authority under 65-28a03(b), on May 15, 2019 and June 14, 2019

the Board requested Licensee provide proof of compliance with the Kansas Health Care

Stabilization Fund ("KHCSF") requirements set forth in K.S.A. 40-3404. Licensee did not

acknowledge or respond to either of these requests.

6. On August 2, 2019, it was confirmed with the KHCSF Licensee had not been

compliant with KHCSF requirements since January 1, 2017.

7. On August 2, 2019, the Board sent additional correspondence requesting proof of

compliance with the KHCSF, informing Licensee how he could become compliant, and informing

him that failure to comply would result in discipline including a fine and indefinite suspension of

his license.

8. Licensee did not respond to this request until October 2, 2019, and at that time did

not provide the required proof of compliance.

9. On October 28, 2019, a representative of KHCSF informed the Board Licensee had

reported to them he was in compliance with KHCSF requirements through a particular insurance

company; that upon inquiry with that insurance company KHCSF Licensee was not one of its

insured; and that KHCSF had requested Licensee provide proof of his insurance.

10. To date, KHCSF has received no response from Licensee regarding proof of

insurance.

11. To date, Licensee has still not provided the Board with proof of compliance with

KHCSF statutory requirements.

#### Applicable Law

12. Under the Kansas Physician Assistant Licensure Act, K.S.A. 65-28a03(b):

The board, prior to renewal of an active license, shall require the licensee to submit to the board evidence satisfactory to the board that the licensee . . . has paid the premium surcharges as required by K.S.A. 40-3404, and amendments thereto.

13. K.S.A. 40-3404 states:

In the case of a resident health care provider who is not a self-insurer, the premium surcharge shall be collected in addition to the annual premium for the basic coverage by the insurer.... The certificate of authority of any insurer who fails to comply with the provisions of this subsection shall be suspended pursuant to K.S.A. 40-222, and amendments thereto, until such insurer shall pay the annual premium surcharge due and payable to the board of governors.

- 14. Under K.S.A. 65-28a05(a), a license may be revoked, suspended or limited, or the licensee may be publicly censured or placed under probationary conditions for committing an act of unprofessional conduct.
  - 15. K.A.R. 100-28a-8 defines "unprofessional conduct" in pertinent part as:
    - (b) committing fraud or misrepresentation in applying for or securing an original, renewal, or reinstated license; or
    - (e) willfully or repeatedly violating the Kansas Physician Assistant Licensure Act.

#### **Conclusions of Law**

- 16. The Board has jurisdiction over Licensee as well as the subject matter of this proceeding, and such proceeding is held in the public interest.
- 17. The Board finds Licensee violated K.S.A. 65-28a05(a), as further defined by 100-28a-8(b) by committing fraud or misrepresentation in applying for or securing a renewal license

by misrepresenting on his online renewal form his compliance with the statutory KHCSF

requirements set forth in K.S.A. 40-3404.

18. The Board finds Licensee violated K.S.A. 65-28a05(a), as further defined by

100-28a-8(e), by repeatedly violating the Kansas Physician Assistant Licensure Act in failing to

provide proof of KHCSF compliance, as required by K.S.A. 65-28a03(b), despite multiple

requests.

19. Based on the facts and circumstances set forth herein, the use of summary

proceedings in this matter is appropriate, in accordance with the provisions set forth in K.S.A. 77-

537(a), in that the use of summary proceedings does not violate any provision of law, and the

protection of the public interest does not require the Board to give notice and opportunity to

participate to persons other than Licensee.

IT IS HEREBY ORDERED that Licensee is INDEFINITELY SUSPENDED until

Licensee provides proof of payment of the premium surcharges required under K.S.A. 40-3404.

IT IS FURTHER HEREBY ORDERED that Licensee is assessed a CIVIL FINE in the

amount of \$100.00 for violations of the Kansas Healing Arts Act. Such fine shall be paid to the

"Kansas State Board of Healing Arts", in full, on or before January 15, 2020. All monetary

payments, which shall be in the form of check or money order, relating to this Summary Order
