ORDER OF TERMINATION OF STIPULATION

NOW on this 17th day of February, 1996, comes for conference hearing before the full Board Licensee's request for termination of the Stipulation and Agreement and Enforcement Order of February 15, 1994 between William J. McDowell ("Licensee") and the Board of Healing Arts ("Board"). Kevin K. LaChance, Disciplinary Counsel, appears on behalf of the Board. License does not appear. **Confidential**

After hearing statements from the parties and being duly advised in the premises, the Board makes the following findings of fact, conclusions of law and orders:

1. A Stipulation and Agreement and Enforcement Order ("Stipulation") was entered into between Licensee and the Board on February 15, 1994.
2. Paragraph 12 of said Stipulation provides that Licensee may petition the Board for rescission and/or modification of the Stipulation after one year has elapsed from the date his signature appears on the Stipulation.
3. Licensee submitted his request for modification or termination of the Kansas Stipulation on February 1, 1996.

4. On February 17, 1996, Licensee entered a Voluntary Entry of Appearance and Waiver of Notice for hearing on this matter set for February 17, 1996 at 10:30 a.m.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that any and all restrictions and limitations placed on Licensee's license to practice medicine and surgery in the State of Kansas by the Stipulation and Agreement and Enforcement Order filed February 15, 1994 should be terminated and be of no further force or effect.


