**FINAL ORDER FOLLOWING CONFERENCE HEARING**

NOW, on the 17th day of October, 1998, this matter comes before the Kansas Board of Healing Arts ("Board") sitting as a whole, upon the request of Arthur Iain McGhie, M.D. (hereafter "Applicant") for waiver of approval by the Council of Education of the American Medical Association regarding post-graduate training.

Applicant appears pro se.

After reviewing the file, hearing statements and being otherwise duly advised in the premises, the Board finds as follows:

1. On August 3, 1998, Applicant filed an Application for Endorsement to obtain a permanent license to practice medicine and surgery in the State of Kansas.
2. Applicant did not graduate from an accredited school of medicine.
3. As part of his application, Applicant provided information and documentation regarding his postgraduate training. The information reflected that Applicant has obtained more than 2 years postgraduate training which is equivalent to training approved by the Council of Education of the American Medical Association.
3. The Board reviewed the application and determines that Applicant's postgraduate

training satisfies the requirements of K.A.R. 100-6-2.

4. Applicant is licensed in the State of Texas and is eligible for a license by endorsement under K.S.A. 65-2833.


**IT IS THEREFORE ORDERED** as follows:

- a) That the findings here and above made be and the same are the Order of the Board.
- b) Applicant has met the requirements of K.A.R. 100-6-2 in that he has provided evidence of completion of 2 years of postgraduate training approved by the Board.


