SUMMARY ORDER EXTENDING TEMPORARY LICENSE

NOW, on this 14th day of December, 2002, the request made on behalf of Shawn McGowan, PA ("Licensee") to extend temporary license comes before the Kansas State Board of Healing Arts ("Board") in summary proceedings pursuant to K.S.A. 77-537. Charlene K. Abbott, Licensing Administrator, presents information to the Board. There are no other appearances.

After reviewing the file, hearing statements from the Licensing Administrator, and being duly advised in the premises, the Board makes the following findings and orders:

1. On September 26, 200~~1~~², Licensee was issued temporary license number 0225771 to expire on September 26, 2002.
2. Licensee passed the examination required for permanent license, but proof of passage of the examination was not provided to the Board office until August 20, 2002.
3. Following receipt of proof of passage of the examination required for permanent license, Licensee's application for permanent license was placed on the Board agenda for approval at the next regular meeting of the Board to be held October 12, 2002, at which time Licensee was issued permanent license number 15-00844 effective that date.
4. K.S.A. 2001 Supp. 65-28a07 authorizes the Board to extend a temporary license, upon a majority vote of the members of the Board, for a period not to exceed one year.

5. Licensee was eligible for a permanent license from and after August 20, 2002, and good and sufficient reasons exist to retroactively extend temporary license number 0225771 from September 26, 2002, until ~~August~~ ^{October 12, 2002} 12, 2002, the date permanent license number 15-00844 became effective.


IT IS THEREFORE ORDERED that Licensee's temporary license number 0225771 that originally expired September 26, 2002, be retroactively extended until October 12, 2002, the date a permanent license was issued to him.

This is a Summary Order and either party is entitled to a review if a written request is received in the Board office within 15 days of service of the Order upon the parties. If no request is received, this Order will become immediately effective.
